A LOCAL LAW WITH REFERENCE TO ATTENDANCE AT SCHOOLS AND COLLEGES BY COUNTY OFFICERS AND EMPLOYEES.

Introduced by Legislator Gary Buckingham, Chairman of the County Officers and Employees Committee.

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

Section 1. The County of Lewis may incur obligations for all expenses necessarily incurred for the use and benefit of the County and paid by any county officer or employee in executing the duties of his office or position, including and limited to actual and necessary expenses for travel, books and materials and tuition charges in connection with attendance at schools and colleges.

Section 2. Such expenses and obligations must receive the prior approval of the Board of Legislators and be subject to such rules and regulations as such Board shall adopt.

Section 3. That this local law shall take effect upon all legal requirements being met.

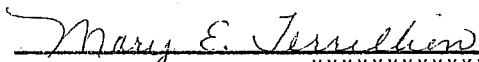

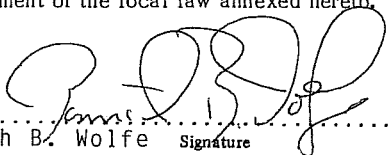
