Local Law No. 7 of the Year 2005

**A LOCAL LAW AMENDING LOCAL LAW NO. 1 - 2003
AND AUTHORIZING AN APPLICATION FOR REVISIONS
TO THE EMPIRE ZONES IN LEWIS COUNTY**

(Insert Title)

BE IT ENACTED by the Board of Legislators of the County of Lewis as follows:

SECTION 1. TITLE. This Local Law shall be known as “**A LOCAL LAW AMENDING LOCAL LAW NO. 1 - 2003 AND AUTHORIZING AN APPLICATION FOR REVISIONS TO THE EMPIRE ZONES IN LEWIS COUNTY**”

SECTION 2. LEGISLATIVE FINDING AND PURPOSE.

- (A) Section 969(c)(1) of the General Municipal Law provides that the Commissioner of Economic Development may authorize a revision to Empire Zone borders provided that a change in circumstances has occurred since the establishment of the existing borders which makes revision of such borders necessary or desirable.
- (B) The Board of Legislators has determined that a change of circumstances has occurred with respect to the Empire Zones that were allocated in the Local Law No. 1 – 2003 to wind turbine generating facilities; in that the several of the locations of such facilities have been adjusted due to (i) geological conditions at the site; (ii) transactional issues that arose between the developer and one or more landowners which necessitated relocating some towers; and/or (iii) one or more additional landowners have become interested in leasing property to the developer for such facilities.
- (C) The Board of Legislators further determines that none of the forgoing circumstances were known at the time that Local Law No. 1 – 2003 was enacted.
- (D) The Board of Legislators, along with many other state and local elected and municipal officials recognize that this is a regionally significant project and have been working diligently with FLATROCK WINDPOWER, LLC, a limited liability company with its local offices located at 7612 State Street, Lowville, New York

13367, and FLATROCK WINDPOWER II, LLC (its assignee), a limited liability company with its local offices located at 7612 State Street, Lowville, New York 13367, the developers of this project, for several years to assist with the development of this project. Such efforts included without limitation, the seeking of and obtaining special legislation authorizing a PILOT program, the negotiation, preparation and execution of a PILOT Agreement, Highway Maintenance Agreement, and many other activities necessary to encourage the this economic development project.

- (E) The Board of Legislators of the County of Lewis has further determined that the revision of the borders of the Empire Zones within the County of Lewis would serve to promote and encourage the expansion of existing business and industry, as well as, to promote the development of new industry within the County. This local law also serves to fulfill the goals of the New York State Empire Zone program described in Article 18-B of the General Municipal Law.
- (F) The County of Lewis is eligible to revise the boundaries to those portions of the Empire Zone as apply to the wind power generating facilities and hereby amends and modifies the Lewis County Empire Zone boundaries as set forth in Local Law No. 1 – 2003.

SECTION 3. EMPIRE ZONE BOUNDARY REVISIONS. The County of Lewis is hereby authorized to revise, amend and modify the Empire Zones within Lewis County. The Empire Zones as described in Local Law No. 1 – 2003 are hereby amended by deleting Schedule”A” therein and substituting the following Schedule therefor: “A”.

SECTION 4. SAVINGS CLAUSE. Except as specifically revised, amended or modified herein, the provisions of Local Law No. 1 – 2003 shall remain in full force and effect.

SECTION 5. EFFECTIVE DATE. This Local Law shall take effect no sooner than:

- (A) Thirty (30) days from the date of the public hearing had herein; and
- (B) Upon filing in the Office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law; and
- (C) Upon approval of these Empire Zone boundary revisions by the Commissioner of the Department of Economic Development.

Copies of the boundary maps and legal descriptions are on file with the Clerk of the Board of Legislators and are available for public inspection.

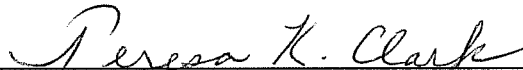

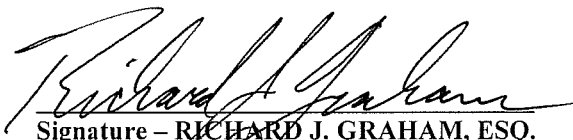
